Deborah is recognized as a leading advocate with a broad commercial and civil litigation practice. Her significant mandates include cases involving complex commercial agreements, director and officer liability, banking litigation, commercial real estate disputes, fraud claims, shareholder and partnership disputes, insolvency proceedings and securities-related matters over a wide cross-section of industries. She is a skilled trial and appellate lawyer, appearing regularly in the Ontario Superior Court of Justice and in the negotiation, mediation and private arbitration of commercial disputes.
