Rachel provides practical and strategic advice to her clients. She has experience representing banks, lenders, debtors, receivers, trustees, court-appointed monitors and purchasers. She has extensive experience with cross-border and international mandates.

Rachel currently serves as Past Chair of the Turnaround Management Association Toronto Chapter's Next Gen Committee, and previously served in various roles as a Director with the International Women's Insolvency and Restructuring Confederation (IWIRC) - Ontario Network. Rachel is also a member of the International Insolvency Institute Next Gen Leadership Program. Rachel regularly speaks on panels on a broad range of insolvency topics.
